

# BetaPro Equal Weight Canadian Bank -2x Daily Bear ETF

#### **REASONS TO CONSIDER**

ATMD offers investors the opportunity to amplify their exposure to Canada's prominent banking sector, providing approximately -2x daily performance of the Solactive Equal Weight Canada Banks Index.

ATMD seeks <u>daily investment results</u>, before fees, expenses, distributions, brokerage commissions, and other transaction costs, that endeavour to correspond to two times (200%) the inverse (opposite) of the daily performance of the Solactive Equal Weight Canada Banks Index. **ATMD does not seek to achieve its stated investment objective over a period of time greater than one day.**
