BITI.U offers a unique opportunity to potentially profit from declining bitcoin prices without the need for a margin account, as well as allowing investors to hedge against downside risk in the cryptocurrency market.

#### Taking Advantage of Volatility

BITI.U offers a strategic opportunity to take a directional view of the world's oldest and largest digital currency, which can experience greater price volatility relative to equities and fixed-income investments.

#### Eligible for Registered Accounts

BITI.U's structure as an ETF allows it to be held within registered accounts like RRSP, RESP, and TFSA, providing tax advantages and broader accessibility for investors seeking to diversify their portfolios, relative to investing in Bitcoin directly.

### INVESTMENT OBJECTIVE

BITI.U is designed to **provide daily investment results**, before fees, expenses, distributions, brokerage commissions and other transaction costs that endeavour to correspond to **up to** one-times (100%) the inverse (opposite) of the daily performance of an index that replicates the returns generated over time through long notional investments in Bitcoin Futures. The current Underlying Index of BITI.U is the BetaPro Bitcoin Front Month Rolling Futures Index (Excess Return). **BITI.U does not seek to achieve its stated investment objective over a period of time greater than one day.**
