BITI.U offers a unique opportunity to potentially profit from declining bitcoin prices without the need for a margin account, as well as allowing investors to hedge against downside risk in the cryptocurrency market.

BITI.U offers a strategic opportunity to take a directional view of the world's oldest and largest digital currency, which can experience greater price volatility relative to equities and fixed-income investments.

Eligible for Registered Accounts

BITI.U's structure as an ETF allows it to be held within registered accounts like RRSP, RESP, and TFSA, providing tax advantages and broader accessibility for investors seeking to diversify their portfolios, relative to investing in Bitcoin directly.

INVESTMENT OBJECTIVE

BITI.U seeks to provide daily investment results, before fees, expenses, distributions, brokerage commissions and other transaction costs that endeavour to correspond to up to one-times (100%) the inverse (opposite) of the daily performance of an index that replicates the returns generated over time through long notional investments in Bitcoin Futures. The current Underlying Index of BITI.U is the Horizons Bitcoin Front Month Rolling Futures Index (Excess Return). BITI does not seek to achieve its stated investment objective over a period of time greater than one day.

DEFINITIONS

Volume: Real-time volume on the Toronto Stock Exchange only.

Included in the Leveraged and Inverse Leveraged ETFs and the Inverse ETFs are the BetaPro Marijuana Companies 2x Daily Bull ETF ("HMJU") and BetaPro Marijuana Companies Inverse ETF ("HMJI"), which track the North American MOC Marijuana Index (NTR) and North American MOC Marijuana Index (TR), respectively. The Leveraged and Inverse Leveraged ETFs and certain other BetaPro Products use leveraged investment techniques that can magnify gains and losses and may result in greater volatility of returns. Currently, the manager expects the hedging costs to be charged to HMJI and borne by unitholders will be between 10.00% and 45.00% per annum of the aggregate notional exposure of HMJI's forward documents. The hedging costs may increase above this range. The manager publishes on its website, the updated monthly fixed hedging cost for HMJI for the upcoming month as negotiated with the counterparty to the forward documents, based on the current market conditions.
