CNDD offers investors double the inverse (opposite) exposure to the daily performance of the S&P/TSX 60™ Index, providing a strategic tool to potentially profit from declines in the large-cap segment of the Canadian stock market.

Target Level Exposure Without Margin

CNDD allows investors to gain leveraged short exposure to large-cap Canadian equities without the need for a margin account, mitigating the risks associated with margin trading while still accessing amplified performance and offering a more controlled approach to leveraged investing.

Acting Hedge

CNDD can serve as an effective hedging tool for investors with long positions in the S&P/TSX 60™ Index, allowing them to hedge out daily or short-term market risk on their holdings. By providing inverse exposure to large-cap Canadian equities, CNDD helps investors mitigate potential losses during market downturns, thereby protecting their investment portfolios and preserving capital.

INVESTMENT OBJECTIVE

CNDD seeks **daily investment results**, before fees, expenses, distributions, brokerage commissions and other transaction costs, that endeavour to correspond to two times (200%) the inverse (opposite) of the daily performance of the S&P/TSX 60™ Index. **CNDD does not seek to achieve its stated investment objective over a period of time greater than one day.**
