
DLR is a low-cost way to invest in currencies, with no additional fees or margin requirements associated with trading currencies directly.

#### **DEFINITIONS**

Annualized Distribution Yield: The most recent regular distribution (excluding additional year end distributions) annualized for frequency, divided by current NAV.

Net Assets: The value of all assets, less the value of all liabilities, at a particular point in time. (Includes all classes of this ETF.)
