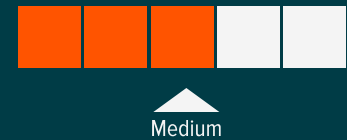

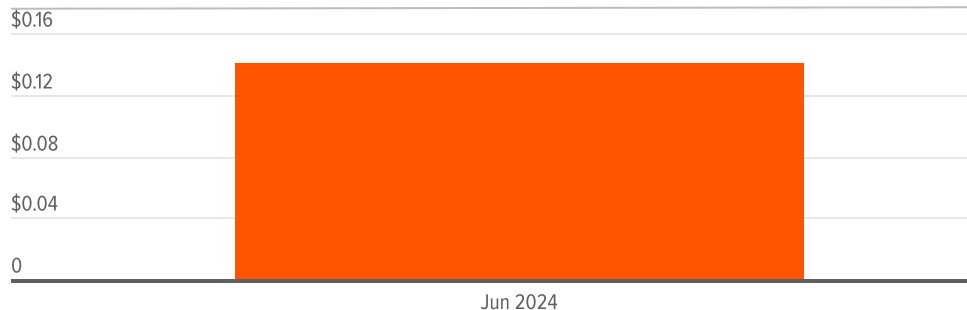

DEFINITIONS
