REASONS TO CONSIDER

2X Leveraged Short Exposure to Gold Bullion

GLDD enables investors to potentially benefit from short-term fluctuations in gold prices by providing amplified inverse exposure to the daily performance of gold futures. It seeks to correspond to two times (200%) the daily performance of the Solactive Gold Front Month MD Rolling Futures Index ER.

Target Level Exposure Without Margin

GLDD allows investors to gain leveraged exposure to gold bullion without the need for a margin account, mitigating the risks associated with margin trading while still accessing amplified performance, offering a more controlled approach to leveraged investing.

Short-Term Speculation Opportunity

GLDD offers an opportunity for short-term speculation on gold price movements, providing investors with a tool to take advantage of daily fluctuations in the gold futures market. This can be particularly attractive for traders seeking to capitalize on short-term trends in gold prices.

INVESTMENT OBJECTIVE

GLDD seeks **daily investment results**, before fees, expenses, distributions, brokerage commissions and other transaction costs, that endeavour to correspond to two times (200%) the inverse (opposite) of the daily performance of the Solactive Gold Front Month MD Rolling Futures Index ER. GLDD is denominated in Canadian dollars. **GLDD does not seek to achieve its stated investment objective over a period of time greater than one day.**
