

REASONS TO CONSIDER

2X Leveraged Short Exposure to Gold Bullion

HBD enables investors to potentially benefit from short-term fluctuations in gold prices by providing amplified inverse exposure to the daily performance of gold futures. It seeks to correspond to two times (200%) the daily performance of the Solactive Gold Front Month MD Rolling Futures Index ER.

Target Level Exposure Without Margin

HBD allows investors to gain leveraged exposure to gold bullion without the need for a margin account, mitigating the risks associated with margin trading while still accessing amplified performance, offering a more controlled approach to leveraged investing.

Short-Term Speculation Opportunity

HBD offers an opportunity for short-term speculation on gold price movements, providing investors with a tool to take advantage of daily fluctuations in the gold futures market. This can be particularly attractive for traders seeking to capitalize on short-term trends in gold prices.

INVESTMENT OBJECTIVE

HBD seeks daily investment results, before fees, expenses, distributions, brokerage commissions and other transaction costs, that endeavour to correspond to two times (200%) the inverse (opposite) of the daily performance of its Referenced Futures Index. HBD is denominated in Canadian dollars. Any U.S. dollar gains or losses as a result of the ETF's investment will be hedged back to the Canadian dollar to the best of its ability.

DEFINITIONS

Volume: Real-time volume on the Toronto Stock Exchange only.

Due to the high cost of borrowing the securities of marijuana companies in particular, the hedging costs charged to HMJI are expected to be material and are expected to materially reduce the returns of HMJI to unitholders and materially impair the ability of HMJI to meet its investment objectives. Currently, the manager expects the hedging costs to be charged to HMJI and borne by unitholders will be between 10.00% and 45.00% per annum of the aggregate notional exposure of HMJI's forward documents. The hedging costs may increase above this range. The manager publishes on its website, the updated monthly fixed hedging cost for HMJI for the upcoming month as negotiated with the counterparty to the forward documents, based on the current market conditions.

The VIX ETF, which is a 1x ETF, as described in the prospectus, is a speculative investment tool that is not a conventional investment. The VIX ETF's Target is highly volatile.
