2X Leveraged Short Exposure to Canadian REITs

HRED offers investors double the inverse (opposite) exposure to the daily performance of the Solactive Equal Weight Canada REIT Index, providing a strategic tool to potentially profit from declines in Canadian REITs.

Target Level Exposure Without Margin

HRED allows investors to gain leveraged short exposure to the Canadian REITs sector without the need for a margin account, mitigating the risks associated with margin trading while still accessing amplified performance and offering a more controlled approach to leveraged investing.

Active Hedge

HRED can serve as an effective hedging tool for investors with long positions in the Canadian REIT sector, allowing them to hedge out daily or short-term market risk on their holdings. By providing inverse exposure to Canadian REITs, HRED helps investors mitigate potential losses during market downturns, thereby protecting their investment portfolios and preserving capital.

INVESTMENT OBJECTIVE

HRED seeks daily investment results, before fees, expenses, distributions, brokerage commissions and other transaction costs, that endeavour to correspond to two-times (200%) the inverse (opposite) of the daily performance of the Solactive Equal Weight Canada REIT Index (the "Underlying Index"). HRED does not seek to achieve its stated investment objective over a period of time greater than one day.

DEFINITIONS

Volume: Real-time volume on the Toronto Stock Exchange only.

Due to the high cost of borrowing the securities of marijuana companies in particular, the hedging costs charged to HMJI are expected to be material and are expected to materially reduce the returns of HMJI to unitholders and materially impair the ability of HMJI to meet its investment objectives. Currently, the manager expects the hedging costs to be charged to HMJI and borne by unitholders will be between 10.00% and 45.00% per annum of the aggregate notional exposure of HMJI's forward documents. The hedging costs may increase above this range. The manager publishes on its website, the updated monthly fixed hedging cost for HMJI for the upcoming month as negotiated with the counterparty to the forward documents, based on the current market conditions.
