RITD offers investors double the inverse (opposite) exposure to the daily performance of the Solactive Equal Weight Canada REIT Index, providing a strategic tool to potentially profit from declines in Canadian REITs.

Target Level Exposure Without Margin

RITD allows investors to gain leveraged short exposure to the Canadian REITs sector without the need for a margin account, mitigating the risks associated with margin trading while still accessing amplified performance and offering a more controlled approach to leveraged investing.

Active Hedge

RITD can serve as an effective hedging tool for investors with long positions in the Canadian REIT sector, allowing them to hedge out daily or short-term market risk on their holdings. By providing inverse exposure to Canadian REITs, RITD helps investors mitigate potential losses during market downturns, thereby protecting their investment portfolios and preserving capital.

INVESTMENT OBJECTIVE

RITD seeks **daily investment results**, before fees, expenses, distributions, brokerage commissions and other transaction costs, that endeavour to correspond to two times (200%) the inverse (opposite) of the daily performance of the Solactive Equal Weight Canada REIT Index. **RITD does not seek to achieve its stated investment objective over a period of time greater than one day.**
