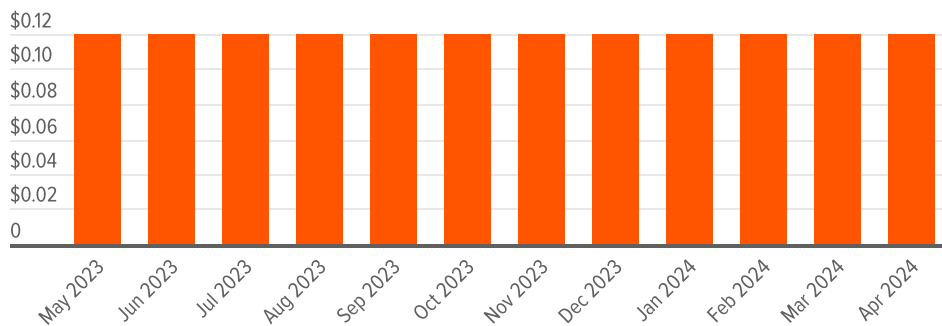

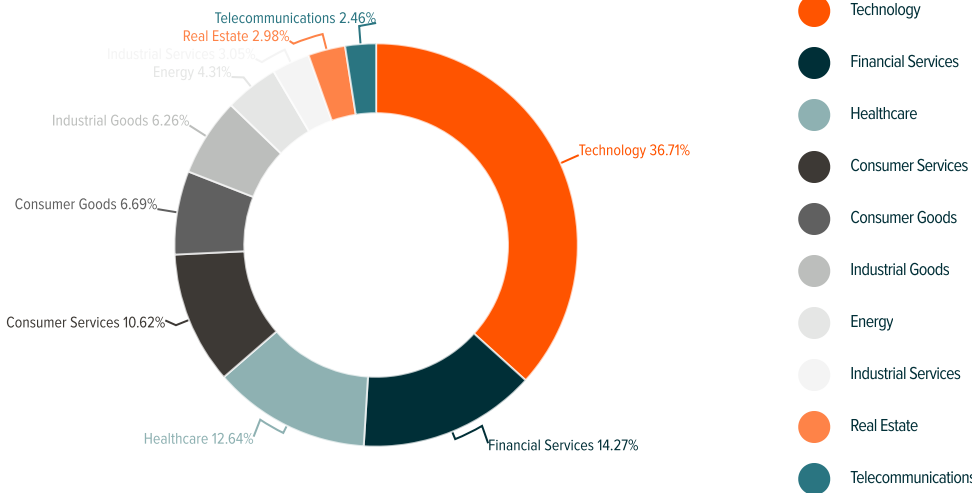

**DEFINITIONS**
